15.Multidisciplinary / interdisciplinary

Guru Nanak Institute of Pharmaceutical Science and Technology (GNIPST) is a well recognized autonomous Pharmacy institute In Eastern India affiliated to Maulana Abul Kalam Azad University of Technology (MAKAUT) and Pharmacy Council of India (PCI).

GNIPST being an autonomous Pharmacy institute follows the curriculum prescribed by PCI and adopted by MAKAUT.

Pharmacy is in itself a multidisciplinary subject as it has components of science, arts, technology and management for example Communication skills, Computer applications, Environmental sciences, Jurisprudence and marketing management. The subjects taught are also interdisciplinary in nature for example Microbiology, Biotechnology, research methodology and biostatistics etc.

Different value added courses are offered to the students on subjects like pharmacovigilance, quality control and standardization, apart from the subjects covered in the syllabus

The has a MOU with Coursera. As an outcome of this MOU, the students can opt for any one course from Coursera once per semester without any payment from the student's end i.e two free courses per year. The students can choose different subjects as per their wish.

The institute has a local chapter of NPTEL. The students take different NPTEL or other MOOCS courses as they wish.

16.Academic bank of credits (ABC):

Guru Nanak Institute of Pharmaceutical Science and Technology has initiated the process of opening Academic Bank of Credits accounts for the students of the institute. GNIPST has registered in National Academic Depository (NAD) on July , 2023 bearing a registration number NAD064640. Subsequently a sample CSV template for grade card was generated and the template was shared to examination management agency for generating data for uploading in Digilocker. ABC ids (APAR id) was created for all M.Pharm 2 nd year, B.Pharm 3 rd year, B.Pharm 2 nd year students.

17.Skill development:

Guru Nanak Institute of Pharmaceutical Science and Technology arranges for different skill development programs for the

students from time to time to increase their employability and entrepreneurship skills.

Two courses on "Pharmacovigilance" and " Quality control and standardizations of herbals " were conducted by the institute in AY 2022-23.

The course " Quality control and standardizations of herbals " was conducted in collaboration with "Herbs and Drugs", a Herbal pharmaceutical company. The institute has an active MOU with Herbs and Drugs.

The Course and training on " Pharmacovigilance" was organized in collaboration with WIPRO.

GNIPST has an active MOU with COURSERA. The students can opt for one course each semester free of cost. They choose the courses based on their area of interest and the skills they want to acquire.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Pharmacy is an interdisciplinary subject wherein traditional knowledge is integrated in different courses offered for example knowledge of Ayurveda, Unani, Sidhdha in Pharmacognosy. Traditional knowledge of drugs and discovery of newer drugs from these knowledge system also plays a part in Pharmacology and Medicinal Chemistry. The subject dispensing pharmacy also incorporates traditional knowledge of drug dispensing and evolution of dosage forms.

The students are encouraged to acquaint themselves with the traditional Indian Knowledge system in form of their Mandatory Additional Requirements (MAR). The students have to acquire 25 marks each semester in form of their MAR points. These MAR points can be accrued from different online courses they take as well as from different activities they take part in that uphold Indian knowledge system like different cultural activities, activities that help them to understand the importance of nature and upkeep of it, activities that help

19.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

GNIPST's adoption of OBE has involved several key strategies:

- **Assessment Transformation:** Assessments have moved beyond rote memorization tests. Projects, simulations, case studies, and presentations are increasingly used to measure students' ability to apply concepts in realistic contexts. Continuous formative assessment provides both students and instructors valuable insights into progress towards the outcomes.
- **Industry Alignment:** GNIPST has actively collaborated with industry partners to ensure that the defined outcomes mirror the skills and knowledge most in-demand within the pharmaceutical sector. This ensures that graduates are well-prepared for successful careers upon entering the workforce.

The shift toward OBE at GNIPST has had a positive impact on student learning:

- **Greater Clarity:** Students have a clearer understanding of expectations from the outset. This focus on outcomes fosters student motivation and self-direction within their learning process.
- **Skill Development:** The emphasis on applied learning has boosted students' practical and problem-solving abilities. They are better equipped to tackle real-world challenges within the pharmaceutical field.
- **Enhanced Engagement:** Active learning methodologies embedded in the OBE framework have led to greater student engagement and participation in the classroom.
- **Improved Employability:** The alignment of outcomes with industry needs has the potential to translate into smoother transitions into the workforce and enhanced career prospects for GNIPST graduates.

Guru Nanak Institute of Pharmaceutical Science and Technology was awarded autonomous status by University Grants Commission (UGC) vide letter No. F.22-1/2017(AC) dated 17TH February 2021, with effect from 2020-2021 admission batch.

The Institute imparts technical education in the field of Pharmacy and is recognised by Pharmacy Council of India (PCI), affiliated to Maulana Abul Kalam University of Technology (formally known as West Bengal University of Technology) since 2005 and is accredited by NAAC and NBA since 2016.

The Board of Studies and Academic Council of Institute has framed the curriculum and syllabus strictly following the syllabus of Pharmacy Council of India.

Following the guidelines of UGC and PCI, GNIPST has implemented various measures to ensure the relevance of the Curricula to the local, national, regional and global developmental needs. These measures are reflected in the Programme Outcomes (POs), Programme Educational Objectives (PEOs) and Course Outcomes (COs) of the various Programmes offered by the Institution, including:

1. Outcome based learning pedagogy to align with Institutional Vision, Mission and address developmental needs at various levels.
2. The Departmental Academic Committee (DAC) of the Institute identified the GAPS in curriculum, based on Industry requirements to meet and fixed the targeted attainment level of COs and POs.

4. The Academic Council diligently implemented the required modifications and upgraded the Curriculum to align with the vision and mission of the Institute, aiming to achieve a global standard.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

The institutional infrastructure is meticulously categorized to encompass various essential facilities.

Classrooms: GNIPST has 8 spacious classrooms of 75 square meters each for B.Pharm and 7 classrooms of 36 square meters each for M.Pharm comprising of essential Teaching amenities like green boards, writing desks, chairs, projectors, screens, dais, podiums with both WIFI and LAN networks with 50Mbps internet.

Flipped Classroom: GNIPST stands as an Eastern India pioneer in flipped learning methodologies. The institution has three dedicated flipped classrooms furnished with interactive smart boards featuring recording systems, cameras, USB connectivity, microphones, and amplifiers. Specially arranged circular desks facilitate collaborative group activities.

Tutorial Rooms: GNIPST provides 2 dedicated rooms furnished with writing desks, chairs, green boards, lighting, fans, and seamless WIFI and LAN connectivity.

Laboratories: 12 laboratories for B.Pharm and 13 for M.Pharm of 75 square meters each.

Centre of Excellence: A dedicated research laboratory, the APC Roy Advanced Research Lab, spanning 300 square meters. A machine room and incubation centre cater to the research and development requirements of the institution.

Animal House compliant with CPCSEA standards

Medicinal Plant Garden hosting over 70 different species.

Computer Facilities including a dedicated computer lab and an e-library with 50 Mbps internet connectivity, supporting technological advancements.

Language Lab equipped with computers, interactive audio visual system and interactive language software.

Library with over 12,360 volumes, 1,322 titles, 132 eBooks, and access to 174 international and 470 national journals.

Specially arranged circular desks facilitate collaborative group activities.

Tutorial Rooms:GNIPST provides 2 dedicated rooms furnished with writing desks, chairs, green boards, lighting, fans, and seamless WIFI and LAN connectivity.

Laboratories:12 laboratories for B.Pharm and 13 for M.Pharm of 75 square meters each.

Centre of Excellence:A dedicated research laboratory, the APC Roy Advanced Research Lab, spanning 300 square meters. A machine room and incubation centre cater to the research and development requirements of the institution.
